


#### The A.A. Groups: "...the groups have final authority.

But how do the groups make their thoughts and wishes — their group conscience — known to the rest of the triangle?
General service is organized to do exactly this. Each section of the triangle has a role to play."

## **CONCEPT** I

"The entire structure of A.A. depends upon the participation and conscience of the individual groups, and how each of these groups conducts its affairs has a ripple effect on A.A. everywhere. Thus, we are ever individually conscious of our responsibility for our own sobriety and, as a group, for carrying the A.A. message to the suffering alcoholic who reaches out to us for help."


**General service representative (GSR)**: Working via the district and area committees, <u>the GSR is the group's link with the General Service Conference</u>, through which U.S. and Canadian groups share their experience and voice A.A.'s collective conscience.

Sometimes called "**the guardians of the Traditions**," GSRs become familiar with A.A.'s Third Legacy — our spiritual responsibility to give service freely.

We are serving during Panel 74 Covers Years: 2024 - 2025


Each Panel is 2 years.

### THE GROUP

The group meets to form a group conscience on proposed changes or actions on matters relating to A.A. as a whole.

The group's elected general service representative, or **GSR**, is tasked with:

- making sure the group's conscience is heard and fully considered at the district and the area

### The Area


Your Area holds 4 assemblies that include **GSRs** as voting members. The **GSR** attends to learn what is occurring in A.A. as a whole and in your local area.

### The Conference

Before the Conference Meeting: Your Delegate will ask to seek your Group Conscience on the Agenda Items coming to the yearly Conference.

After the Conference meeting: Your Delegate reports back on the Conference proceedings.

#### **General Service Board** Composition

#### **General Service Board (GSB)**

Our General Service Board is a not-forprofit comprised of: 7 Class A Trustees (Non-Alcoholics) & 14 Class B Trustees (Alcoholics): Responsible and responsive to the Fellowship through the General Service Conference. Concerned with matters affecting the primary purpose of carrying the A.A. message to the stillsuffering alcoholic.

#### **Alcoholics Anonymous World Services** (AAWS)

Oversees the service and publishing activities of the General Service Office (GSO) in the U.S. and Canada, as well as communications with A.A. service entities and offices around the world Publishes and distributes A.A. books. pamphlets and other items

#### **Alcoholics Anonymous Grapevine** (AAGV)

Oversees the Grapevine office, Publishes and distributes the A.A. Grapevine magazine and the Spanish edition, La Viña, Publishes and distributes Grapevine books and other content-related items.







The role of the GSR is essential to ensuring that groups can fulfill that <u>responsibility</u>.

Only when a GSR keeps the group informed and communicates the group conscience can the Conference truly act for A.A. as a whole.

This communication is a two-way street, making the GSR responsible not only for bringing forward the group's voice, but for taking back to the group Conference actions that affect the Fellowship's unity, health and growth.







## "WHAT IS THE ROLE OF A GSR?"

When the GSR is <u>present</u> at assemblies and district meetings, the group's voice is heard.

 The presence of a GSR says their group cares about what's going on in the Fellowship and wants to learn and make its concerns and suggestions known.





## "WHAT IS THE ROLE OF A GSR?"

When the GSR participates, the group's voice is heard.

- It can be through a GSR sharing the group's concerns across a conference table from other GSRs in a district meeting.
- It can be through questioning a budget item or proposing an idea important to the group at an area assembly.
- It can be through making an impassioned plea about an agenda item to the delegate on the eve of the annual General Service Conference meeting.



## "WHAT IS THE ROLE OF A GSR?"

When the GSR votes, the group's voice is heard.

- The GSR votes on the trusted servants to lead the district and the area as well as the delegate to represent the area at the annual General Service Conference meeting.
- The group's voice is heard when the GSR votes on matters presented before the District and the Area voting body.





## ROLE OF THE ALTERNATE GSR

"An alternate GSR is elected at the same time in the event that the GSR may be unable to attend all district and area meetings. Alternate GSRs should be encouraged to share the responsibilities of the GSR at the group, district and area levels."

- The A.A. Group...where it all begins (Pamphlet P-16)

- It is just as important for Alternate GSRs to be active and involved in the service role as it is with the GSR. Work together!
- If, as a GSR, you are not able to attend a District meeting or Area assembly, the Alternate GSR needs to be just as familiar with the proceedings as the GSR.

- Please be sure both you and your Alternate GSR are receiving the District 7 Communications.
- These notifications contain information on upcoming service assemblies, service meetings, updates from our Delegate and important information from both the Area and District, and much more are included in those e-mails.

- If you have not completed the **Group Information Change Form**, please do so.
- The change form provides the District, Area and AAWS knowledge of who is serving and is utilized for communication and e-mails. <u>Group Information Change Form</u>
- Submitting the form also triggers for you to receive a GSR Kit via mail (if you made this selection on the form).
- Alternate GSRs do not receive a Kit. However, all information is available <u>online</u> and can be ordered via <u>AAWS on aa.org</u>.

#### Tradition Seven (excerpt)


"The A.A. groups themselves ought to be fully supported by the voluntary contributions of their own members."

- With ample time, inform your group of upcoming Service Events where Travel, Hotel & Food expenses may be incurred.
- Provide an estimate in advance for your group to review and decide how best to support the Group being represented at the service events.
- Ride share and Hotel Room share with other GSRs in your District may help to lessen the expense on groups.

#### Why does the Group need to reimburse me if I can personally afford it?


Our support of services actually amounts to a recognition on our part that A.A. must everywhere function in full strength — and that, under our Tradition of self-support, we are all going to foot the bill."





## CARRYING THE VOICE OF THE A.A. HOME GROUP

Tradition 2 Short Form: "For our group purpose there is but one ultimate authority – a loving God as he may express himself in our group conscience. Our leaders are but trusted servants, they do not govern."



## WHAT IS AN INFORMED A.A. GROUP CONSCIENCE?

The group conscience is the <u>collective conscience</u> of the group membership and thus represents substantial unanimity on an issue before definitive action is taken.

#### **How to Achieve:**

This is achieved by the group members through <u>the sharing of full</u> <u>information, individual points of view</u>, and the <u>practice of A.A. principles</u>.

To be fully informed <u>requires a willingness to listen</u> to <u>minority opinions</u> <u>with an open mind</u>.

On <u>sensitive issues, the group works slowly</u> — discouraging formal motions until a clear sense of its collective view emerges. Placing principles before personalities, the membership is <u>wary of dominant opinions</u>.

#### The Result:

Its voice is heard when a <u>well-informed group</u> arrives at a decision. The <u>result rests on more than a "yes" or "no" count</u> — precisely because it is <u>the</u> <u>spiritual expression of the group conscience</u>.

### LEADERSHIP IN A.A.: EVER A VITAL NEED CONCEPT IX ESSAY

"First let's remember that the base for our service structure rests on the dedication and ability of several thousand General Service Representatives (G.S.R.'s), several hundred area Committee Members, and nearly a hundred Delegates.

These are the direct agents of the A.A. groups; these are the indispensable linkage between our Fellowship and its world service; these are the primary representatives of A.A.'s group conscience. Without their support and activity we could not operate permanently at all."

- "A leader in A.A. service is therefore a man (or woman) who can personally put principles, plans and policies into such dedicated and effective action that the rest of us want to back him up and help him with his job."
- Our leaders do not drive by mandate, they lead by example." In effect, we are saying to them, "Act for us, but don't boss us."
- Another qualification for leadership is "give and take," the ability to compromise cheerfully whenever a proper compromise can cause a situation to progress in what appears to be the right direction."
- "Vision is...the ability to make good estimates, both for the immediate and for the more distant future."
- "We shall be in continual need of these same attributes—tolerance, responsibility, flexibility, and vision—among our leaders of A.A. services at all levels."

### Intergroup Liaison (Coastal Bend Intergroup Association = CBIA)

Importance:

- A central office or intergroup is an A.A. service office that involves partnership among groups in a community — just as A.A. groups themselves are partnerships of individuals.
- A central office/intergroup is established to carry out certain functions common to all the groups functions that are best handled by a centralized office and it is usually maintained, supervised and supported by these groups in their general interest.
- It exists to aid the groups in their common purpose of carrying the A.A. message to the alcoholic who still suffers.

### - Treatment Facilities (T.F.)

Importance:

- Members of Treatment Committees work to carry the A.A. message into treatment settings where suffering alcoholics, and the professionals who treat them, may be introduced to A.A.



#### WHY DO WE NEED A CONFERENCE?

The late Bernard B. Smith, nonalcoholic, then chairman of our board of trustees, and one of the architects of the Conference structure, answered that question superbly in his opening talk at the 1954 meeting:

"We may not need a General Service Conference to ensure our own recovery. We do need it to ensure the recovery of the alcoholic who still stumbles in the darkness one short block from this room. We need it to ensure recovery of a child being born tonight, destined for alcoholism. We need it to provide, in keeping with our Twelfth Step, a permanent haven for all alcoholics who, in the ages ahead, can find in A.A. that rebirth that brought us back to life.

"We need it because we, more than all others, are conscious of the devastating effects of the human urge for power and prestige which we must ensure can never invade A.A. We need it to ensure A.A. against government, while insulating it against anarchy; we need it to protect A.A. against disintegration while preventing overintegration. We need it so that Alcoholics Anonymous, and Alcoholics Anonymous alone, is the ultimate repository of its Twelve Steps, its Twelve Traditions, and all of its services.

"We need it to ensure that changes within A.A. come only as a response to the needs and the wants of all A.A., and not of any few. We need it to ensure that the doors of the halls of A.A. never have locks on them, so that all people for all time who have an alcoholic problem may enter these halls unasked and feel welcome. We need it to ensure that Alcoholics Anonymous never asks of anyone who needs us what his or her race is, what his or her creed is, what his or her social position is."

- ? Has your Home Group changed any days, times or locations of our meetings lately?
- ? Planning on attending upcoming District or Area service Events?
- ? Recently attended a District or Area service event? Share briefly on 1 or 2 items that caught your attention, that you have questions on or that you brought back to your group.


